

Processing charges for various Quality control activities were prescribed by the Directorate vide Office Order No. 06/2002 dated. 22.11.2002. Considering the hike in various operational costs, proposals received from various Regional/Sub offices of DMIs and with the approval of the competent authority, the processing charges for various are revised and prescribed as under:

1.	Grant of C.A for Centralised commodities (Internal & Export) and Decentralised commodities for Export through packer's own Laboratory/SGLs/Commercial/Co-operative/Association Laboratories.	Rs. 10000
2.	Renewal of C.A for internal & Export trade through packer's own Laboratory/SGLs/Commercial/Co-operative/Association Laboratories.	Rs. 5000
3.	Grant of C.A to grade & mark Decentralised commodities for Internal grading.	Rs.10000
4.	Issue of duplicate C.A.	Rs. 5000
5.	Approval of Commercial/Association/Co-operative Labs.	Rs. 10000
6.	Renewal of Commercial/Association/Co-operative Labs.	Rs. 5000
7.	Grant of permission to Printing Press to print Agmark Replica.	Rs. 10000
8.	Renewal of permission to printing press to print Agmark replica.	Rs. 5000
9.	Change of Grading laboratory from SGL/Commercial/Association/Co-operative laboratory to own laboratory.	Rs. 5000
10.	Inspection of authorised premises and / or laboratory for making endorsement in the same C.A. for another commodity or for internal/export trade.	Rs. 5000
11.	Change of premises of packer having own laboratory/ attached to SGL/ Commercial/Association/ Co-op. laboratory.	Rs. 5000
12.	Change of premises of Commercial/Association/Co-operative Laboratory.	Rs. 5000
