- 2) The transfers of the above-mentioned officers are in public interest and hence they are entitled for TTA, joining time, etc. admissible as per rules.
- 3) All the Controlling Officers shall ensure the relieving of the transferred officers on the earliest possible date. Else, all such transferred officers, who have not been relieved till that date, shall automatically stand relieved on **30th June, 2024 (AN)**, unless the officer has been expressly allowed to stay beyond such date with the approval of AS(M)-cum-AMA. Mere submission of request for extension of time, etc. would not entitle the officer to delay his/her joining at new place of posting beyond the prescribed date.
- 4) It is also requested that all the above officers on their relieving shall ensure that all the GeM related login ID and password should be transferred in the name of the In-charge/successors.
- 5) All the Controlling Officers shall also ensure that the transferred officer who have been engaged with duties or whose names have been sent for engagement in General Election for Lok Sabha, 2024, shall be relieved/dislocated till the election process is over.
- 6) This order is being issued after obtaining "No Objection" from the Election Commission of India from MCC angle.
